MOST RECENT GRANTS AND LATEST UPDATES

Pipeline Investment Program

The Pipeline Investment Program (PIPE) provides grants to construct the last few miles of natural gas distribution lines to business parks, existing manufacturing, and industrial enterprises, which will result in the creation of new economic base jobs in the commonwealth while providing access to natural gas for residents.

Funds may be used for acquisition, construction, and site preparation costs associated with extending natural gas pipelines to serve eligible applicants. The maximum grant amount of any Pipeline Investment Program project award shall not exceed \$1.5 million or 50% of the total project costs, whichever is less. In addition to the maximum grant amount, the CFA may provide grants for tapping costs not to exceed \$500,000. An eligible applicant shall provide matching funds of not less than 50% of the total project cost.

Eligibility: Applicants can apply for eligible projects that include natural gas extension, large residential conversion projects, or combined heat and power projects. Upon approval and receipt of a commitment letter, the grant agreement must be electronically signed by the grantee and returned to the CFA within 45 day of the date of the commitment letter or the offer may be withdrawn by the CFA.

Enrollment: Applications are considered on a rolling basis.

Commonwealth Financing Authority

The Commonwealth Financing Authority (CFA) was established in 2004 as an independent agency of the Department of Community and Economic Development (DCED) to administer Pennsylvania's economic stimulus packages. The CFA holds fiduciary responsibility over the funding of programs and investments in Pennsylvania's economic growth. Unique among state agencies in structure and scope, the CFA consists of seven Board members: four legislative appointees and the secretaries of DCED, the Office of the Budget and the Department of Banking and Securities. Project approval requires five affirmative votes, four of which must come from legislative appointees.

Act 13 Programs

The Marcellus Legacy Fund was created by Act 13 of 2012 to provide for the distribution of unconventional gas well impact fees to counties, municipalities, and commonwealth agencies. Pursuant to Section 2315 (a) (6) (i) of the Act, a portion of the fee revenue will be transferred to the Commonwealth Financing Authority (CFA) for statewide initiatives that will include abandoned mine drainage abatement; abandoned well plugging; sewage treatment; greenways, trails, and recreation; baseline water quality data; watershed restoration; and flood control.

Abandoned Mine Drainage Abatement and Treatment Program

Act 13 of 2012 established the Marcellus Legacy Fund and allocated funds to the CFA for abandoned mine drainage, abatement, and treatment with the Abandoned Mine Drainage Abatement and Treatment Program (AMDATP). Abandoned Mine Drainage (AMD) is one of the largest sources of stream impairment in Pennsylvania. Billions of gallons of AMD impair over 5,500 miles of streams within the Commonwealth. Grants shall be awarded to eligible applicants for projects that do not exceed \$1,000,000. The grant requires at least a 15% local match of the total project cost. The grant requires a 15% local cash match of the total project cost.

Eligibility: Applicants can apply for eligible projects such as Abandoned Mine Land (AML) reclamation projects, construction of new AMD remediation projects, repair of existing AMD remediation project sites, operations and maintenance of costs associated with maintaining current operating AMD remediations, monitoring water quality, projects that use AMD for oil and gas well development, and projects using new technology or research methods to study or design new treatment measures to abate/reduce AMD.

Enrollment: Applications will be accepted annually from February 1 to May 31.

Act 13 Programs (continued)

Baseline Water Quality Data Program

Act 13 of 2012 established the Marcellus Legacy Fund and allocates funds to the CFA to be used to fund statewide initiatives to establish baseline water quality data on private water supplies using the Baseline Water Quality Data Program (BWQDP). Grants shall be awarded to eligible applicants for projects that do not exceed \$250,000. The grant requires a 15% local cash match of the total project cost. Match commitment documentation is required to be provided along with the application.

Eligibility: Applicants can apply for eligible projects that will use accepted scientific principles and practices or water sample collection, and analysis, to document existing groundwater quality conditions on private water supplies.

Enrollment: Applications will be accepted annually from February 1 to May 31.

Act 13 Programs (continued)

Flood Mitigation Program

Act 13 of 2012 established the Marcellus Legacy Fund and allocates funds to the CFA funding statewide initiatives to assist with flood mitigation projects. Grants shall not exceed \$500,000 for any project and are required to have at least a 15% match of the total cost. Further, to be eligible for reimbursement, costs must be incurred within the time frame established by the grant agreement, except costs related to engineering design.

Eligibility: Applicants can apply for eligible projects authorized by a flood protection authority, the PA Department of Environmental Protection (DEP), the U.S. Army Corps of Engineers (Corps) or the U.S. Department of Agriculture's Natural Resources Conservation Service (NRCS) or identified by a local government for flood mitigation. Further, grants are awarded to eligible applicants for projects with a total cost of \$50,000 or more.

Enrollment: Applications will be accepted annually from February 1 to May 31.

Act 13 Programs (continued)

Greenways, Trails, and Recreation Program

Act 13 of 2012 established the Marcellus Legacy Fund and allocates funds to the CFA for planning, acquisition, development, rehabilitation and repair of greenways, recreational trails, open space, parks, and beautification projects using the Greenways, Trails, and Recreation Program (GTRP). Grants shall not exceed \$250,000 for any project, and a 15% local cash match of the total project cost is required.

Eligibility: Applicants can apply for eligible projects such as public parks and recreation areas, greenways and trails, or rivers and conservation.

Enrollment: Applications will be accepted annually from February 1 to May 31.

Orphan or Abandoned Well Plugging Program

Act 13 of 2012 established the Marcellus Legacy Fund and allocates funds to the CFA for funding orphan or abandoned well plugging projects using the Orphan or Abandoned Well Plugging Program (OAWP). Pennsylvania has had hundreds of thousands of oil and gas wells drilled since 1859. This program provides a mechanism to plug abandoned and orphaned wells that have the potential to cause health, safety, or environmental concerns. There is a maximum of \$1,000,000 for any project. Match commitment documentation is required to be provided along with the application.

Eligibility: Applicants can apply for eligible projects that include the cleaning out and plugging of abandoned and orphan oil and gas wells, stray gas mitigation systems, and well venting projects.

Enrollment: Applications will be accepted annually from February 1 to May 31.

Sewage Facilities Program

Act 13 of 2012 established the Marcellus Legacy Fund and allocates funds to the CFA for statewide initiatives for complying with the Act of January 24, 1966 (1965 P. L. 1535, No. 537), known as the Pennsylvania Sewage Facilities Act. Grants shall be awarded to eligible applicants up to \$100,000. A 50% match of the total project cost is required.

Eligibility: Eligible applicants can apply for funds that can be used by the applicant to pay for eligible project costs such as costs associated with the planning work required under the PA Sewage Facilities Act or administrative costs of the applicant necessary to administer the grant (with restrictions). Sewage Facilities Planning projects to complete a new or make changes to an existing Act 537 plan. The Task/Activity Report for this project must be submitted and approved by DEP prior to submission of the grant application.

Enrollment: Applications will be accepted annually from February 1 to May 31.

Act 13 Programs (continued)

Watershed Restoration and Protection Program

Act 13 of 2012 established the Marcellus Legacy Fund and allocates funds to the CFA for watershed restoration and protection projects. The overall goal of the Watershed Restoration and Protection Program (WRPP) is to restore and maintain restored stream reaches impaired by the uncontrolled discharge of nonpoint source polluted runoff, and ultimately to remove these streams from the Department of Environmental Protection's Impaired Waters list. There is a maximum of \$300,000 for any project and a 15% match of the total project cost is required.

Eligibility: Applicants can apply for eligible projects relating to watershed restoration/protection projects implementing runoff control or runoff reduction BMPs on agricultural operation or addressing urban or residential areas negatively impacting local or regional stream quality; watershed projects that refurbish, restore or create stream bank or stream channel stabilization; repair and maintenance of existing watershed BMPs; and monitoring of water quality.

Enrollment: Applications will be accepted annually from February 1 to May 31.

Building PA

The CFA, through the Building Pennsylvania Program, provides loans to fund managers for investment in real estate projects within the Commonwealth.

The Building Pennsylvania Program is a Commonwealth of Pennsylvania initiative intended to address these financing needs. By providing \$150 million in loans to real estate fund managers, another \$150 million of private capital will be leveraged, creating a total pool of \$300 million which will be available to finance high impact real estate projects within the Commonwealth. Focused on industrial, commercial, and multi- use projects, the program will support the acquisition, development, redevelopment, and revitalization of communities. In order to focus capital investments in traditionally underserved areas, the commonwealth has earmarked 50% of the funds to be made available for those real estate projects located in areas other than cities of the first and second class. All loans are made pursuant to the statutory authority of the CFA.

Building Pennsylvania Program provides loans to real estate fund managers for investment in real estate projects within the Commonwealth. The program provides loans focused on industrial, commercial and multi-use projects on investments in traditionally underserved areas; further, 50% of the funds to be made available are located in areas other than cities of the first and second class.”

Business in Our Sites Program

The Business in Our Sites Program provides grants and loans for the acquisition and development of key sites for future use by businesses, private developers, and others. The program is administered through the CFA and is intended to provide financial assistance to municipalities and others to plan and prepare sites for future use. Projects which require site development assistance where a business has already committed to locating at a specific site or where a private developer has already committed to locating a facility for a specific user may also seek financial assistance under other appropriate programs administered by the Department of Community and Economic Development (DCED).

There is no maximum or minimum loan amount. However, the amount of the grant may not exceed \$4 million or 40% of the total combined grant and loan award, whichever is less. Private developers are only eligible for loans.

Loans will be repaid over a period not to exceed 20 years. The interest rate for the loan will be 2% or 3% depending on the unemployment rate of the county where the project is located when the CFA is in a first lien position. If the CFA is in a subordinate lien position, the interest rate will be 8% or 9% based on the unemployment rate of the county where the project is located.

Eligibility: Applicants can apply for eligible projects such as previously utilized sites or undeveloped sites, and all applicants must present a plan to manage and market the development of the site and demonstrate there is substantial likelihood of future use of the site after the property is made shovel-ready so that the property will ultimately generate economic growth and increase employment opportunities in the surrounding community.

Multimodal Transportation Fund

The Multimodal Transportation Fund (MTF) program provides grants to encourage economic development and ensure that a safe and reliable system of transportation is available to the residents of this commonwealth.

The program is intended to provide financial assistance to municipalities, councils of governments, businesses, economic development organizations, public transportation agencies and rail and freight ports in order to improve public transportation assets that enhance communities, pedestrian safety, and transit revitalization.

Funds may be used for the development, rehabilitation, and enhancement of transportation assets to existing communities, streetscape, lighting, sidewalk enhancement, pedestrian safety, connectivity of transportation assets and transit-oriented development. Grants are available for projects with a total cost of \$100,000 or more. Grants shall not exceed \$3 million for any project.

Eligibility: Applicants can apply for eligible projects that include a project that coordinates local land use with transportation assets to enhance existing communities; a project related to streetscape, lighting, sidewalk enhancement and pedestrian safety; a project improving connectivity or utilization of existing transportation assets, and a project related to transportation aspects of transit-oriented development.

New PA Venture Capital Investment Program

The New PA Venture Capital Investment Program provides loans to venture capital partnerships for investment in Pennsylvania-related companies. The nature of the investments by the venture capital partnerships is intended to be equitable or convertible debt.

The program provides flexible financing is designed to meet the needs of technology-oriented businesses and is adaptable to the newly developed business structures evolving in the technological economy.

A venture capital partnership is an entity whose purpose is to make investments in companies and is formed as a limited partnership, limited liability company, or comparable investment entity.

Eligibility: Applicants can apply for eligible projects where the ultimate beneficiary of the financing must be a Pennsylvania related company, or an entity willing to locate significant business operations in the Commonwealth; there is financial return mechanism to the program, and the fund applicant must be willing to provide all pertinent information requested to complete a due diligence review of the proposed investment in the venture capital partnership.

PA Small Water and Sewer

The PA Small Water and Sewer Program was established by the H2O PA in 2008, and act authorizes the Commonwealth Financing Authority to award grants to municipalities and municipal authorities for water, sewer, storm water and flood control projects with a cost of not less than \$30,000 and not more than \$500,000.

Pipeline Investment Program

The Pipeline Investment Program (PIPE) provides grants to construct the last few miles of natural gas distribution lines to business parks, existing manufacturing, and industrial enterprises, which will result in the creation of new economic base jobs in the Commonwealth while providing access to natural gas for residents.

Funds may be used for acquisition, construction, and site preparation costs associated with extending natural gas pipelines to serve eligible applicants. The maximum grant amount of any Pipeline Investment Program project award shall not exceed \$1.5 million or 50% of the total project costs, whichever is less. In addition to the maximum grant amount, the CFA may provide grants for tapping costs not to exceed \$500,000. An eligible applicant shall provide matching funds of not less than 50% of the total project cost.

Upon approval and receipt of a commitment letter, the grant agreement must be electronically signed by the grantee and returned to the CFA within 45 days of the date of the commitment letter or the offer may be withdrawn by the CFA.

Public School Facility Improvement Grant

The Public School Facility Improvement Grant was created to provide grants to public school districts and area career and technical schools for eligible facility improvement projects and is administered by DCED under the direction of the CFA.

Funds may be used for roof repairs and roof replacement; heating, ventilation, and air conditioning equipment; boilers and controls; plumbing systems; energy-saving projects; health and safety upgrades; emergencies; accessibility projects; internet connectivity; demolition; window repairs; and window replacement. School entities are eligible to apply. "School Entity" is defined as a school district or area career and technical school.

Grants are available for eligible projects with a total project cost of \$500,000 or more. Grants shall not exceed \$5 million for any project. A single grant cannot exceed 75% of the total eligible costs, projects require a cash match of 25% of total eligible costs.

Tax Increment Financing Guarantee Program

The Tax Increment Financing Guarantee Program promotes the general economic welfare of various regions and communities in the Commonwealth of Pennsylvania and assists in the development, redevelopment and revitalization of brownfield and greenfield sites through the use of Tax Increment Financing (TIF) in accordance with the Tax Increment Financing Act of July 11, 1990, as amended, 53 P.S. §6930.1 et seq. (the “TIF Act”).

Any issuer of TIF Debt Obligations for a project located within a municipality, other than a city of the first or second-class, may apply to the Tax Increment Financing Guarantee Program. Eligible issuers under the TIF Act include all municipal authorities, industrial and commercial development authorities, and redevelopment authorities including boroughs, townships, towns, counties, and home rule municipalities.

The maximum amount that the CFA will pay under its guarantee is \$5 million, inclusive of principal and interest. Guarantee amounts will be determined by the scope of the project, the estimated projections of future tax revenues to be generated by the project, the estimated financing cost savings realized through the provision of a guarantee, and the ability of the CFA to assume the rights to security provided to the holders of the TIF project debt in the event of a default.

Eligibility: Eligible applicants that issue TIF bonds to fund local economic development projects can apply for eligible projects that meet the minimum criteria set by the program.

Pennsylvania Malt and Brewed Beverage Industry Promotion Program

The Pennsylvania Malt and Brewed Beverage Industry Promotion Program was created by state law, and up to \$1 million in funding may be allocated annually by the Pennsylvania Liquor Control Board (PLCB) to the program for the purposes of increasing the production of Pennsylvania-made malt and brewed beverages and enhancing the Pennsylvania malt and brewed beverage industries through promotion, marketing, and research-based programs and projects. The program is administered by five Board members who are appointed by the Governor and the General Assembly. The Board meets throughout the year to solicit, evaluate, and recommend projects to the PLCB for funding.

Funds are made available annually. The request for proposals (RFP) is published annually in the Pennsylvania Bulletin under the Department of Agriculture. This publication usually takes place in January. Proposals are reviewed and recommended by the Pennsylvania Malt and Brewed Beverage Industry Promotion Program Board to the Pennsylvania Liquor Control Board for funding.

Eligibility: Funds shall be used for enhancing the Pennsylvania malt and brewed beverage industry through promotion, marketing, and research-based programs and projects.

Enrollment: The grant became effective January 1, 2025. Grant agreements will be effective for 12 months for marketing, educational and/or promotions-related projects, and for 18 months for research projects. Proposals should be sent to RA-AGCOMMODITIES@pa.gov within the application period.

Dirt, Gravel, and Low Volume Road Maintenance Program

The Dirt, Gravel and Low Volume Road Maintenance Program (DGLVR) is an innovative non-point source pollution control program for local municipal road officials. Under this program, the State Conservation Commission provides grant funding through county conservation districts to state and local entities to eliminate stream pollution caused by runoff and sediment from dirt, gravel, and low volume roads. Eligible applicants are state and local entities that own public roads. Federal roads and privately owned roads are not eligible for grant funds.

The Commission provides an annual allocation to local conservation districts based on the amount of eligible roads and identified pollution sites in a county. The conservation district, based on the local DGLVR program policy, award grants to eligible public road-owning entities.

Public entities such as townships, cities and boroughs may apply to the conservation districts for grant funding. Conservation districts establish their own grant application periods.

Eligibility: Eligible applicants can apply for grants to be used for expenses related to the implementation of environmentally sound road maintenance practices on dirt and gravel roads and low volume paved roads.

Community Development Block Grant

This program provides grants and technical assistance for eligible municipalities as identified under Pennsylvania Act 179 of 1984 as amended, for any eligible community development activities. Uses for funds include housing rehabilitation, public services, community facilities, infrastructure improvement, development, and planning. Foundations In Industry Training

The Foundations in Industry Training (FIT) Grant Program is a statewide program which offers assistance to registered apprenticeship programs. The program's goal is to increase apprenticeship availability to Pennsylvania employers to assist them with their talent recruitment and development.

Local Government Capital Project Loan Program

The Local Government Capital Project Loan Program is administered by the Governor's Center for Local Government Services of DCED. Pennsylvania Industrial Development Authority (PIDA)

The PIDA provides low-interest loans and lines of credit for eligible businesses that commit to creating and retaining full-time jobs and for the development of industrial parks and multi-tenant facilities.

Loan applications are packaged and underwritten by a network of certified economic development organizations (CEDOs) that partner with PIDA to administer the program.

A variety of different industry sectors are eligible for PIDA financing including manufacturing, industrial, agricultural, research and development, hospitality, defense conversion, recycling, construction, child day-care, retail and service, export, and computer-related service enterprises.

Pennsylvania Minority Business Development Authority (PMBDA)

The PMBDA program provides low-interest loans to businesses owned and operated by ethnic minorities. Eligible applicants include any businesses owned and operated by ethnic minorities, except non-franchised restaurants. PMBDA can finance up to 90% of the eligible total project costs, or \$250,000, whichever is less. Funds from other sources must equal at least 10% of PMBDA eligible project costs.

The interest rate for PMBDA loans will be fixed at 2% at the time the loan is approved and will remain fixed for the duration of the repayment term. Interest rates are subject to change from time to time. Up to 15-year term for land and buildings; up to 10-year term for machinery and equipment; up to 3- year term for working capital. May subordinate lien position; \$50,000 cost per job for new jobs created, and \$35,000 cost per job for jobs retained.

Eligibility: Eligible applicants can apply for funding for land, building, machinery and equipment costs, as well as working capital.

Pennsylvania Minority Business Development Authority Revolving Loan Fund Capitalization Program

This program provides a source of funds with extended payment terms to successful Community Development Financial Institutions (CDFIs) and community-based Revolving Loan Funds (RLFs) to make low-interest loans to businesses owned and operated by ethnic minorities. The maximum loan amount is \$400,000 per applicant, and the interest rate is 1.5% for a period of 5 years.

Pennsylvania Strategic Investments to Enhance Sites Program

The Pennsylvania Strategic Investments to Enhance Sites Program (PA SITES) was established to provide grant funding to eligible applicants to develop competitive sites for businesses to relocate or expand within the Commonwealth. The program is administered by the Pennsylvania Department of Community and Economic Development (DCED) through the Pennsylvania First Program (PA First).

The program is intended to serve as gap financing for strategic sites that need financial assistance to help reduce development risk for businesses. The grant funding is intended to help finance strategic investments that will enhance sites across the Commonwealth to effectively compete for expanding and relocating businesses. The program will help reduce development risk for businesses by timeline reduction from the development of public infrastructure or reducing unknown development costs.

The maximum grant award for any one planning project is \$250,000 and no more than \$5 million in the aggregate in grant funds will be provided as planning grants to eligible applicants.

Eligibility: Eligible applicants can apply for funding to fund the development of a comprehensive real estate plan according to program guidelines.

Section 1721-A.2 of Subarticle C of the Fiscal Code (Act 176 of 1929) establishes the Sports Tourism and Marketing Account within the Pennsylvania Gaming Economic Development and Tourism Fund as a restricted account. Strategic Management Planning Program

The Strategic Management Planning Program (SMPP) was designed to offer a pre-emptive step for municipalities who are realizing financial difficulties and seeking to improve their financial position. The program supports municipalities by offering grants that can be used to fund costs associated with hiring an independent financial consultant to prepare a three-to five-year financial plan and management review of their municipality. Established on July 1, 1995, the Pennsylvania Department of Conservation and Natural Resources (DCNR) is charged with maintaining state parks, managing state forest land, and providing information on the state's ecological and geological resources. The department is also responsible for establishing community conservation partnerships with grants and technical assistance to benefit rivers, trails, greenways, local parks and recreation, regional heritage parks, open space, and natural areas. DCNR's mission is to conserve and sustain Pennsylvania's natural resources for present and future generations' use and enjoyment.

Rivers Conservation Grants and Community and Watershed Forestry Funding

Rivers Conservation projects focus on protecting and enhancing the conservation or recreation value of Pennsylvania's waterways. Applications are submitted under the appropriate primary grant category. For example, funding for a Rivers Conservation Plan would be requested through a Community Recreation and Conservation Planning grant application; an easement or purchase to protect a headwaters area would require a Land Acquisition and Conservation grant.

The DCNR Community & Watershed Forestry Program provides financial assistance to identify locations in need of riparian forest buffers, lawn conversion, and urban tree-planting and to design, implement, and establish those practices. This program supports projects that produce conventional buffers and multifunctional buffers -- a buffer type that provides an opportunity to harvest products such as nuts, berries, woody florals, forbs, and potentially woody biomass in addition to the conventional buffer of riparian tree and shrub species.

Volunteer Fire Assistance Grants

The U.S. Department of Agriculture provides financial, technical, and other assistance to state officials in cooperative efforts to organize, train, and equip local forces in rural areas or communities under 10,000 in population to prevent, control, and suppress fires which threaten rural areas. The key objectives of this program are to save lives and protect property in unprotected or inadequately protected rural areas. Therefore, the selection of the participating agencies must be based on vulnerability and the adequacy of existing fire protection.

This is a cost-share program. Financial assistance on any project during any fiscal year cannot exceed 50 percent of the actual expenditures -- including expenditures of local, public, and private nonprofit organizations participating in the agreement.

Eligibility: Eligible applicants can apply for grants to be used for the purchase of wildlife and suppression equipment, wildfire protective gear, mobile or portable radios, installation of dry hydrants, wildfire prevention and mitigation, wildfire training, and certain projects involving the conversion and maintenance of federal excess vehicles received from the DCNR Bureau of Forestry and used for fire suppression.

Alternative Fuel Vehicle Rebate Program

Pennsylvania residents can apply for a rebate when they purchase a new alternative fuel vehicle (AFV). The Alternative Fuel Vehicle Rebate Program was established under Act 178 of 2004 to help reduce Pennsylvania's dependence on imported oil and to improve environmental quality by using alternative fuels. A rebate request must be submitted no later than six months after the vehicle is purchased. The rebate will be offered on a first-come-first served basis if funding is available.

Eligibility: Eligible applicants can apply for funding for new alternative fuel vehicles or pre-owned, with stipulations, and any alternative fuel vehicle used by a retail location or online retail service for demonstration purposes as outlined by program guidelines.

Alternative Fuels Incentive Grants

Grant funding is available for clean, alternative fuel projects in Pennsylvania and investment in Pennsylvania's energy sector. DC Fast Charging & Hydrogen Fueling Grant Program

This is a competitive grant program that provides funding for new, publicly accessible DC Fast Charging and Hydrogen Fueling projects built in strategic locations in Pennsylvania and designed to supply light duty vehicles. Grant funding is available for up to 70% of project costs, capped at \$500,000 per award for hydrogen fueling projects and \$250,000 for DC fast charging projects.

Electric Cargo Handling Grant Program

The Electric Cargo Handling Grant Program is a competitive grant program that provides funding for the repower or replacement of diesel-powered forklifts (with a lift capacity of greater than 8,000 pounds), Tier 0-2 airport ground support equipment, and port cargo handling equipment. Eligible vehicles must be scrapped and replaced with the same equipment in an all-electric form. Grant funding is available for up to 60% of project costs for government applicants and up to 40% for non-government applicants.

Level 2 EV Charging Rebate

This program provides rebates for new Level 2 Electric Vehicle Charging projects to be installed in public spaces, workplaces, and multi-unit dwellings. Rebates up to \$4,500 per plug are available, though final rebate amount is based upon the project characteristics, cost, and location. The application period is rolling, and applications are reviewed on a first-come, first-served basis.

Successful applicants are issued a 180-day voucher, which can be redeemed for the approved rebate amount upon successful completion of the project and submittal of required documentation.

Marine and Rail Freight Movers Grant Program

This is a competitive grant program that provides funding to (1) repower or replace diesel-powered, pre-Tier 4 freight switcher locomotives, that operate 1,000 hours or more per year, with any new EPA or CARB-certified diesel, alternative fuel, or all-electric engine, or (2) repower or upgrade unregulated, Tier 1 or Tier 2, diesel-powered marine engines in ferries or tugboats with an EPA Certified Remanufactured system or an EPA Verified Engine Upgrade. Grant funding is available for up to 60% of eligible project costs (up to 80% for electric projects), with no maximum dollar amount per award.

Medium and Heavy-Duty Zero-Emissions Vehicle (MHD-ZEV) Fleet Pilot Grant Program Initiative

The primary goal of the Medium and Heavy-Duty Zero Emission Vehicle Pilot ("MHD-ZEV") is to improve the Commonwealth's air quality by reducing NOX emissions from Class 4-8 trucks while driving the transformation from older, polluting diesel engines to cleaner transportation technologies.

Ocean Going Vessel Shorepower Grant Program

The Ocean-Going Vessel Shorepower Grant Program is a competitive grant program that provides funding for the purchase and installation of eligible dock-mounted, containerized, or barge-mounted marine shore power systems at eligible ports in Pennsylvania. Grant funding is available for up to 75% of project costs for government applicants and up to 25% of project costs for non-government applicants.

Onroad Rebate Program

This program provides rebates for Class 4-8 local freight trucks, drayage trucks, school buses, transit buses and shuttle buses. Rebates vary based on vehicle type, fuel, type, and vehicle owner, though the final rebate amount is based upon actual project costs. Maximum rebates are determined by maximum dollar rebate per vehicle or engine, or percentage of total project costs, whichever is less, combined for all vehicles in the application. Between 1 and 5 vehicles may be submitted per application. Applicants proposing more than 5 vehicles should apply to the Truck and Bus Fleet Grant Program. The application period is rolling, and applications are reviewed on a first-come, first-served basis. Successful applicants are issued a 365-day voucher, which can be redeemed for the approved rebate amount upon successful completion of the project and submittal of required documentation.

Truck and Bus Fleet Grant Program

A minimum of 6 vehicles must be submitted per application.

Department of Revenue

The Department of Revenue (DOR) was established in 1927 and is charged with collecting and distributing most of the tax monies due to the Commonwealth of Pennsylvania. On an annual basis, the department receives and collects all of the Commonwealth's General Fund tax revenue. In addition, the department annually processes more than 10 million business and individual tax reports and payments. Property Tax/Rent Rebate Program

The rebate program benefits eligible Pennsylvanians based on age and income criteria. Spouses, personal representatives, or estates may also file rebate claims on behalf of claimants who lived at least one day in the claim year and meet all other eligibility criteria.

The maximum standard rebate is \$1,000, but supplemental rebates for qualifying homeowners can boost rebates to \$1,500.

The Property Tax/Rent Rebate Program is one of five programs supported by the Pennsylvania Lottery. Since the program's 1971 inception, older and disabled adults have received more than \$8 billion in property tax and rent relief. The rebate program also receives funding from slots gaming.

Eligibility: Eligible applicants include Pennsylvania homeowners and renters who are aged 65 and older; widows and widowers aged 50 and older; and people with disabilities age 18 and older. In addition to age requirements, household income must be \$46,520 or less annually.

Enrollment: Applications for 2025 Property Tax/Rent Rebates are being accepted. The deadline to submit your rebate application is June 30, 2026.

Pennsylvania Department of Transportation (PennDOT)

PennDOT oversees programs and policies affecting highways, urban and rural public transportation, airports, railroads, ports, and waterways. More than three-quarters of PennDOT's annual budget is invested in Pennsylvania's approximately 121,000 miles of state and local highways and 32,000 state and local bridges. PennDOT is directly responsible for nearly 40,000 miles of highway and roughly 25,400 bridges, a system first established in 1911.

Roughly 7,095 of PennDOT's complement of nearly 11,579 employees are engaged in the maintenance, restoration, and expansion of the state highway system. They work in central headquarters in Harrisburg and 11 engineering districts, with facilities in all 67 counties.

PennDOT also administers the state's 12.1 million vehicle registrations, and 10.1 million driver's licenses and IDs and oversees safety and emission inspection programs.

Automated Red-Light Enforcement (ARLE) Funding Program

The Automated Red Light Enforcement Transportation Enhancements Grant Program (ARLE Funding Program) was established in 2010 as a PennDOT-administered competitive grant program in accordance with Vehicle Code (75 Pa.C.S.) §3116(l)(2), §3117(m)(2), and §3370(m)(2). Funding for the program is generated from the net revenue of fines collected through Automated Red Light Enforcement Systems and Automated Speed Enforcement Systems. Grant applications are accepted annually during the month of June.

Eligibility: Eligible applicants include local authorities (counties, municipalities, and other boards or bodies having authority to enact laws relating to traffic), Metropolitan Planning Organizations (MPOs), Rural Planning Organizations (RPOs), County Planning Organizations, and Commonwealth agencies. These entities may apply for funding that improves safety at intersections by delivering automated enforcement activity that would otherwise be done by a police officer.

Green Light-Go: Pennsylvania's Municipal Signal Partnership Program

The Green Light-Go: Pennsylvania's Municipal Signal Partnership Program, also known as the "Green Light-Go Program," is a competitive state grant program designed to improve the efficiency and operation of existing traffic signals located in the Commonwealth of Pennsylvania. Established by Act 89 of 2013 and revised by Act 101 of 2016, the program is administered by the Pennsylvania Department of Transportation, Bureau of Maintenance and Operations. The Green Light-Go Program is a reimbursement grant program, and applicants are required to provide a minimum 20 percent match.

Eligibility: Eligible applicants include municipalities, counties, and planning organizations. This includes cities, boroughs, and townships with existing signals. These entities can apply for funding that can be used for a range of operational improvements to existing traffic control signals located in Pennsylvania.

Enrollment: Pre-application scoping forms were required and accepted until January 2, 2026. Full applications must be submitted electronically through the DCED Single Application for Assistance between March 1, 2026 and March 31, 2026. Awards are expected to be announced in July 2026.

PennDOT Multimodal Transportation Fund (MTF)

Act 89 of 2013 established a dedicated Multimodal Transportation Fund to stabilize funding for ports and rail freight, increase aviation investments, and establish dedicated funding for bicycle and pedestrian improvements. The Multimodal Transportation Fund (MTF) provides funding for priority investments in any mode through PennDOT's MTF Statewide Competitive Funding Program.

The MTF program provides grants to ensure that a safe and reliable system of transportation is available to the residents of the Commonwealth. The program is intended to provide financial assistance to municipalities, councils of governments, businesses, economic development organizations, public transportation agencies, and ports and rail freight entities to improve transportation assets that enhance communities, pedestrian safety, and transit revitalization.

Eligibility: Eligible applicants include Municipalities, Councils of Governments, Businesses, Non-Profits, Economic Development Organizations, Public Transportation Agencies, and Ports or Rail/Freight Entities.

Eligible projects specified in Act 89 fall into four categories:

- Projects that coordinate local land use with transportation assets
- Projects improving connectivity or utilization of existing transportation assets
- Projects related to streetscapes, lighting, sidewalk enhancement and pedestrian safety
- Projects related to transit-oriented development

Safe Schools Targeted Grants

Building Resilient Infrastructure and Communities

The BRIC program is an annually funded nationwide competitive grant program; a federal disaster declaration is not required. The BRIC program guiding principles are supporting communities through capability- and capacity- building; encouraging and enabling innovation; promoting partnerships; enabling large projects; maintaining flexibility; and providing consistency. The overall goal of this non-disaster grant is to reduce overall risk to the population and structures from future hazard events, while also reducing reliance on federal funding in future disasters. As with the Flood Mitigation Assistance program, this program is open to any local government or eligible organizations; individuals cannot apply directly for the program. The federal cost share for a PDM project is 75 percent. At minimum, a FEMA-approved local flood mitigation plan is required before a project can be approved. Some funding is available for planning.

Only the Commonwealth of Pennsylvania may apply as an applicant. Sub-applications must come from local governments or other eligible organizations; individuals cannot apply directly for the program.

Eligibility: Eligible applicants include only the Commonwealth of Pennsylvania. Applications must come from local governments or other eligible organizations; individuals cannot apply directly for the program.

According to the department, the Emergency Management Performance Grant (EMPG) encourages the development of comprehensive disaster preparedness and assistance plans, programs, capabilities, and organizations by the states and by county governments. Hazard Mitigation Grant Program

The Hazard Mitigation Grant Program (HMGP) is a grant that requires a federal disaster declaration. The purpose of HMGP is to help communities implement hazard mitigation measures following a Presidential Major Disaster Declaration in the areas of the state, tribe, or territory requested by the Governor or Tribal Executive. The key purpose of this grant program is to enact mitigation measures that reduce the risk of loss of life and property from future disasters.

Once a federally declared disaster is provided to the Commonwealth, municipalities which adopted the county's Hazard Mitigation Plan are eligible. Only the Commonwealth of Pennsylvania may apply as an applicant. Sub-applications must come from local governments or other eligible organizations; individuals cannot apply directly for the program. This program is open to any local government or eligible organizations; individuals cannot apply directly for the program.

Eligibility: Eligible applicants include municipalities which adopted their county's Hazard Mitigation Plan upon granting of a federally declared disaster. These entities can apply for funding for eligible projects according to program guidelines.

High Hazard Potential Dams Grant

The objective of this program is to reduce or eliminate the risk of eligible, high hazard potential dams. The National Dam Safety Program, run by the Federal Emergency Management Agency, protects lives and property from the risks associated with dams.

The Rehabilitation of High Hazard Potential Dams Program makes federal funds available to states for pass-through to non-federal government organizations and nonprofits. The funds are for the rehabilitation of eligible, high-hazard potential dams that don't meet minimum state dam safety standards, posing unacceptable risk to life and property.

Applicants must have a High Hazard Potential Dams Program hazard mitigation action in their county's FEMA-approved county hazard mitigation plan and must have participated in and adopted the county hazard mitigation plan as a special district.

The Pennsylvania Fish and Boat Commission (PFBC) created the Boating Facility Grant Program to provide grants for the planning, acquisition, development, expansion, and rehabilitation of public boating facilities located on the waters of the Commonwealth. The goal of the program is to ensure Pennsylvania's recreational boaters have the highest quality boating facilities.

Boating Facility Grants are available to public entities, including townships, boroughs, municipal and county governments as well as to nonprofit groups (501c3) including land trusts, conservancies and watershed associations that have or will have the capability to provide boat access facilities that are open and available for general public use.

Grants cover up to 50% of costs for land acquisition, project design and engineering, development, expansion, and construction of public recreational boat access facilities. Eligible activities include the rehabilitation, expansion or construction of new boat ramps, bulkheads, courtesy floats, access roads, parking areas, restrooms, signs, and localized landscaping. All construction activities must benefit and directly support recreational boating. Eligible projects must occur on land owned by the project sponsor, or where the sponsor has a long-term lease or agreement on the site. Grant funds are for major site improvements and are unavailable for routine maintenance or operational activities.

Eligibility: Boating Facility Grants are available to public entities, including townships, boroughs, municipal and county governments as well as to nonprofit groups (501c3) including land trusts, conservancies and watershed associations that have or will have the capability to provide boat access facilities that are open and available for general public use.

Boating Infrastructure Grant Program

The Boating Infrastructure Grant Program provides grants for transient moorage (tie-ups) serving recreational motorboats 26 feet and longer. Transient means passing through or by a place, staying 10 days or less. The program is administered in Pennsylvania by the Pennsylvania Fish and Boat Commission, in cooperation with U.S. Department of Interior's U.S. Fish and Wildlife Service.

Grants may be made to public and private operators of open-to-the-public boating facilities: municipal agencies (cities, towns, counties, etc.), state agencies (State Parks, DNR, Fish & Wildlife, etc.), and other government entities.

There are two "tiers" of grant support. Tier 1 provides funding for small-scale projects. Up to \$100,000 is available annually to each state. Tier 2 is for projects that request more than \$100,000. Tier 2 projects compete nationally in a process managed by the US Fish and Wildlife Service.

Eligibility: Eligible applicants can apply for funding for transient tie-ups serving recreational motorboats 26 feet and longer.

R3 Grant Program

Recruitment, retention, and reactivation (R3) of anglers and boaters is important to the Pennsylvania Fish and Boat Commission (PFBC). The R3 Education Grant Program (R3 Grant) provides funding to support R3-related educational programs delivered by our partners. Supporting partners in their efforts to deliver such programming significantly increases the number of learning opportunities provided to current, past, and future anglers and boaters.

Education programs play a role in R3 by providing experiences that increase fishing knowledge and skills, facilitate social support, and provide information on angling and boating opportunities close to home. Funding for the PA State Grant Program may be paid in part or in whole by the Commonwealth of PA. To be considered for a PA State Grant, you must fill out the FAFSA® (Free Application for Federal Student Aid) and complete the PA State Grant Form. Most renewal students do not have to complete the PA State Grant Form.

Eligible applicants for funding must meet the following requirements:

- Be a Pennsylvania resident
- Be enrolled at least half-time
- Be enrolled in a PHEAA-approved program
- Be a high school graduate or have a GED
- Meet financial need criteria
- Make satisfactory academic progress
- Not have already earned a bachelor's degree
- Be of satisfactory character
- Not have received the maximum number of PA State Grants
- Not be in default or pending default on an educational loan

Enrollment:

- **Summer term:** The application for the PA Summer State Grant Program is available online from mid-March to August 15. To be eligible, you must be enrolled at least half-time.
- **Fall and spring term:** The FAFSA must be submitted by May 1, or June 1.
- **Community colleges and designated Pennsylvania Open-Admission institutions:** The FAFSA must be submitted by August 1.
- **Business, trade, or technical schools, hospital schools of nursing, or 2-year programs:** The FAFSA must be submitted by August 1.

Cultural and Historical Support Grant Program

This grant program uses funds placed in PHMC's operating budget by the state legislature and is restricted for this purpose only. Keystone Historic Preservation Planning Grants & Keystone Historic Preservation Construction Grants

As established under the Keystone Recreation, Park and Conservation Fund, funding under the Keystone Historic Preservation Planning and Construction Grant programs is available to nonprofit organizations and local governments for the planning and development for publicly accessible historic resources listed in or eligible for listing in the National Register of Historic Places or for small construction projects for publicly accessible historic resources.

The purpose of Planning Grants are to support projects that identify, preserve, promote, and protect historic and archaeological resources of Pennsylvania for both the benefit of the public and the revitalization of communities.

Reducing Underage and Dangerous Drinking

The PLCB Reducing Underage Drinking and Dangerous DRINKING (RUDD) Grant offers additional resources and funding to eligible community partners to develop and enhance the PLCB's mission to reduce underage drinking, reduce dangerous drinking , and promote responsible alcohol consumption by those of legal drinking age.

Eligibility: Eligible applicants can apply for funding that discourages and reduces underage and dangerous drinking.

Enrollment: The Grant cycle is two years, beginning on July 1, 2026, or the Effective Date, and ending on June 30, 2028. Grants shall be awarded to eligible entities, defined below, on a competitive basis and are capped at \$25,000 per fiscal year. The total maximum award will be \$50,000 per grant cycle, per eligible entity.

Fiscal years are as follows:

- Year 1: July 1, 2026 – June 30, 2027
- Year 2: July 1, 2027 – June 30, 2028

Note: unused dollars from Year 1 will not be transferable to Year 2.

Pennsylvania Infrastructure Investment Authority (PENNVEST)

Since its inception, PENNVEST has continued its service to the communities and citizens of Pennsylvania by funding sewer, storm water and drinking water projects throughout the Commonwealth. These projects not only contribute to improving Pennsylvania's environment and the health of its people, but they also provide opportunities for economic growth and jobs for Pennsylvania's workers.

PENNVEST's low-cost financial assistance helps make the water that is consumed every day by thousands of Pennsylvanians safe to drink. It helps clean rivers and streams in communities for the enjoyment of our citizens and the protection of our natural resources. PENNVEST funding also assists businesses to locate and expand their operations in Pennsylvania to create permanent, well-paying jobs for our workers.

PENNVEST has been empowered by the Pennsylvania Infrastructure Investment Authority Act (Act 16 of 1988) to administer and finance the Clean Water State Revolving Fund (CWSRF) and the Drinking Water State Revolving Fund (DWSRF) pursuant to the federal Water Quality Act of 1987, as well as to administer American Recovery and Reinvestment Act of 2009 (ARRA) funds. PENNVEST also finances, through the issuance of special obligation revenue bonds, water management, solid waste disposal, sewage treatment and pollution control projects undertaken by or on behalf of private entities.

Redevelopment Assistance Capital Program

The Redevelopment Assistance Capital Program (RACP) is a Commonwealth grant program administered by the Office of the Budget for the acquisition and construction of regional economic, cultural, civic, recreational, and historical improvement projects. RACP projects are authorized in the Redevelopment Assistance section of a Capital Budget Itemization Act, have a regional or multi-jurisdictional impact, generate substantial increases or maintain current levels of employment, tax revenues, or other measures of economic activity. RACP projects are state-funded projects that cannot obtain primary funding under other state programs.

RACP projects must have a minimum 50% non-state participation, of which at least one-half must be secured funding. RACP projects must have a total project cost of at least \$1 million. A project is eligible for RACP funding only if that project has been itemized in a Pennsylvania Capital Budget Project Itemization Act, such itemizations have remaining “Project Allocation” amounts and have not been statutorily “sunset” according to Act 77 of 2013. Candidates who have an authorized and eligible project will need to submit an e-RACP Application to the Office of the Budget. Please refer to our website for more detailed information on eligibility, funding schedules, and submission requirements.

There is a 30-day “public comment period” after the closing of an e-RACP Application window until an award can be made. Once the initial review of all the projects has been completed and the public comment period has closed, the Office of the Budget will forward a complete listing of projects and summaries to the Administration for grant award consideration.

THE CAPITAL BUDGET

Overview

The capital budget is how the Commonwealth acquires, constructs, or improves capital assets. Capital assets may include buildings and structures, furnishings and equipment, land or rights to land, infrastructure, and rolling stock. The capital budget also provides grants for certain economic development projects and financial assistance to mass transit agencies and rail companies.

Capital projects may be financed either from current revenues or from bond funds. The Pennsylvania Constitution permits the Commonwealth to incur debt without the approval of the electors for capital projects itemized explicitly in a capital budget if such debt will not cause the amount of all net debt outstanding to exceed one and three-quarters times the average of the annual tax revenues deposited in the previous five fiscal years as certified by the auditor general. The Constitution further provides that all debt incurred for capital projects shall mature within a period not to exceed the estimated useful life of projects as stated in the authorizing law.

The Legislative Process

The Commonwealth budget procedures require the governor to prepare and submit a capital budget to the General Assembly each year as a component of the annual state budget. The governor's capital budget lists projects that the governor is proposing and also provides an estimate of capital expenditures for each of the ensuing five years. Capital expenditures are forecasted for five years into the future because projects are rarely completed in the same year in which they are initiated. The design, bidding, and acquisition or construction phases often overlap several fiscal years. The estimates of capital expenditures are critical because they determine the amount of general obligation bonds that must be issued each year to finance the Commonwealth's capital program.

The Capital Facilities Debt Enabling Act (Act 1 of 1999) governs the capital budget. The Capital Facilities Debt Enabling Act defines the qualifications of a capital project. The act delineates the different types of capital projects and outlines the procedures for preparing a capital project itemization bill and annual capital bond authorization bill. In addition, the act contains debt issuance requirements.

The Legislative Process (continued)

The General Assembly may enact a capital bond authorization act as part of its annual budget deliberations. The Capital Bond Authorization Act specifies the amount of bonds that may be issued in a given fiscal year for capital projects by each project category. The Annual Capital Bond Authorization Act usually does not include itemizations of specific capital projects. Such itemizations are included in capital project itemization acts.

Generally, one capital project itemization bill is considered and enacted each legislative session. Capital project itemization acts are often referred to as “wish lists.”

The inclusion of a capital project in an itemization act does not guarantee that funding will be provided for that project. The administration of the capital budget rests solely with the governor, and he may choose to disapprove projects through the use of the line-item veto. Moreover, many projects that survive the line-item veto are never released and never funded. The Governor’s Office of the Budget oversees the release and timing of projects.

Capital Project Categories:

Public Improvement Projects: All public improvement projects must have at least an estimated five-year useful life. Improvements to existing assets must increase the usefulness or change the use or function of the asset in order to be considered a capital project. Maintenance and repair projects, which are to preserve or restore existing assets, are not considered capital expenditures. Public improvement projects include all types of new buildings and renovation projects. Non-structural improvements and the acquisition of land are also included.

Redevelopment Assistance Capital Projects (RACP): These projects provide grants for the acquisition of land and the construction of buildings and other property improvements for economic development, as well as for capital improvements to hospital facilities and the construction of housing units. RACP funding cannot be used solely for highways, bridges (highway and bridge projects are itemized in a separate bill), waste disposal facilities, sewage systems or facilities, or water systems or facilities. RACP may include roads, bridges, sewer, and water costs in the overall proposal.

Capital Project Categories (continued):

A project is eligible for an RACP grant if it has a cultural, civic, historical, regional, or multi-jurisdictional impact and generates substantial increases in employment, tax revenues, or other measures of economic activity. Grantees must be one of the following:

- a general-purpose form of local government unit (city, borough, township or county)
- any public authority
- a federally designated Local Development District
- an industrial development agency, which has been certified as such by the Pennsylvania Industrial Development Authority (PIDA) board and which is itself or is acting through a wholly owned subsidiary exempt from federal taxation under section 501 (c) (3) of the Internal Revenue Code of 1986. The grantee must follow strict guidelines to avoid jeopardizing the tax-exempt status of the bond funding.

NOTE: A school district - which is a "special purpose of local government" - is not eligible to be a RACP grantee. A school district can be the sub-grantee of an eligible grantee.

RACP's must have a minimum of 50% non-state participation, of which at least one-half must be secured funding. They must have a total project cost of at least \$1 million. Act 25 of 2020 limits the aggregate amount of debt that may be outstanding for redevelopment assistance projects to \$3.1 billion.


Transportation Assistance Projects: These projects are administered by the Department of Transportation (PennDOT) and are generally divided into the subcategories: mass transit, rural and intercity rail projects, and air transportation assistance projects. Mass transit projects are for purchasing rolling stock and constructing or improving facilities operated by mass transit agencies. Rural and intercity rail projects are for acquiring, constructing, and equipping rural and intercity common carrier surface transportation systems. Most projects itemized for air transportation assistance have been improvements to rural airports.

Flood Control Projects: These projects include flood works and improvements to prevent floods in which the federal government is a participant and the location is a designated Federal Flood Control Area. This category provides the state's share of the cost of such projects. Local financial participation is also required.


Capital Budget Flow Chart

RACCP: Pre-award Grant Process Flowchart



RACP: Pre-award Grant Process Flowchart


Pre-award Application Process
